## Support the Protecting Massachusetts Communities campaign



The Protecting Massachusetts Communities (PMC) urges state lawmakers to pass reforms that would enhance the safety of all Massachusetts residents by ensuring a clear division between state and local law enforcement and federal immigration activities.

The PMC coalition is working to establish safeguards to protect our immigrant communities from violent and inhumane immigration enforcement.

The campaign's priorities will defend immigrants by

- Banning new 287(g) agreements
- Preventing partnerships between local law enforcement and ICE
- Prohibit local law enforcement from asking about immigration status and
- Fund legal representation for those facing deportation.
