Who We Are

For nearly 25 years, the Law Office of Susanna L. Shafer has advocated for immigrants to the United States, primarily providing direct representation to asylum seekers, to victims of torture and domestic violence, to people seeking humanitarian relief after disasters in their home country, and to people seeking to be reunited with their family members in the United States. We work both in the U.S. Immigration Court and Federal Court system providing removal defense, as well as assisting people in applying for lawful status with the United States Department of Homeland Security and U S embassies and consulates world-wide. Our office was founded with the goal of addressing the representation gap for hardworking immigrants who may not qualify financially for legal services, but who also cannot afford higher priced, Boston-based representation. To this end, we have strategically established offices in lesser-served areas including Susanna Shafer's hometown of Taunton, Massachusetts, centrally located in Southeastern Massachusetts, as well as in Newton/Needham, accessible to the working communities of Metro West and Boston.

Through our longstanding practices such as free initial consultations, flexible payment plans, and "low bono" pricing, we have had proven success in providing community support and affordable immigration representation to individuals throughout Massachusetts and New England. We are a small private law firm with a welcoming, family-friendly vibe.

Massachusetts Access to Counsel Initiative (MACI)

The Massachusetts Access to Counsel Initiative was founded by the Massachusetts legislature in 2025 in response to recent changes and increased enforcement of the administration's immigration policies. The mission of the program is to ensure due process rights for Massachusetts residents are met during all stages of immigration removal proceedings. Since

December 2025, the Law Office of Susanna L. Shafer has been a subcontractor with MACI, helping to ensure that Massachusetts residents who meet the program's eligibility requirements are represented in their immigration court proceedings. In addition to supervision and training from the law office, MACI will provide the staff attorney with training, resources, and mentorship. - USCIS filings for work cards, U-visas, SIJS, and family adjustments;
- Accompanying clients to ICE check-ins;
- Occasional appearances before the Massachusetts Family and Probate Court; and
- Occasional travel to meet clients without access to transportation.
